REGULATORY ADVANTAGES

The City of Houston has set priorities to support growth and innovation. The city has no local minimum wage, permitting is fast and friendly, and the cost of doing business in Houston is well-below the U.S. major metro average. Additionally, Houston has no personal or corporate income tax.

UNION & LABOR COSTS

Texas is a right-to-work state, ensuring a choice among quality union and non-union skilled labor. Houston boasts one of the lowest unionization rates nationwide with only 2.2% of its private workers unionized, significantly lower than the national rate of 6.5%. Houston has no personal or corporate income tax.

TAX INCENTIVES

Texas and Houston understand the need for a stable, friendly and transparent tax structure. Texas is one of the few states without a personal, state, or corporate income tax, which makes the cost of doing business very competitive. Plus, the personal tax burden in the Houston area consistently ranks among the lowest in the nation, which makes it an attractive place to live and work.
